They offer **hippotherapy** (equine-assisted physical and speech/language therapies) and hydrotherapy (warm, moving water physical therapy). When Timber Creek Therapies was created they also developed Timber Creek Charities, a 501c3 publicly supported non-profit entity. Therapy funding is often limited or non-existent and the founders felt a non-profit charity was critical to providing quality treatment and therapeutic activities to all persons in need.

Now you may ask, "What is hippotherapy?" Specially trained therapists use the movements of a horse as a treatment tool for patients in need of physical, occupational and speech/language therapy. This treatment takes place in a controlled environment following a specific treatment plan. There is an indoor riding arena that allows patients to be treated year-round and an adjoining building houses the pool, treatment rooms, office space and a kitchen where patients receive cognitive retraining.



The pool is a warm-water pool with an electrical current system. This system can move 5,000 gallons of water up to 6.5 miles per hour. The floor of the pool can be raised or lowered making the depth as shallow as 2 feet up to 5 feet deep depending on the patient and their treatment needs. There is also a motorized chair lift to assist individuals into and out of the pool. The moving water provides an effective treatment tool for patients with mobility, gait, trunk control, extremity strength and pain issues.

Timber Creek was founded by Cindy McCarty in 2000. Cindy is a licensed speech/language pathologist and a certified therapist in hippotherapy. Cindy is assisted by several talented individuals – both volunteers and paid staff – to provide the therapies needed for their patients. Some of you may know an Eastern Star member, Gigi Nelson, who has worked as a volunteer for Cindy. In addition, they have several horses that are used to provide hippotherapy.

## "Kruzin' the World from my comfy chair"

Our virtual travels take us to Ohio where we will enjoy the "Nature's Life and Beauty Session." The Grand Officers, or Dragonflies, wore blue jackets with iridescent skirts in peacock-colored swirls as they watched the opening drill which included representatives from Job's Daughters, the Grand Worthy Advisor of Rainbow for Girls, State Master Councilor of DeMolay, Worthy Matrons and Worthy Patrons from the Worthy Grand Matron's and Worthy Grand Patron's districts, and the Worthy Grand Matron's and Worthy Grand Patron's grandsons sent video greetings from where he was stationed. The Worthy Grand Matron had 6 Grand Pages and 3 Grand Aides! New 50 year members were given their pins at Grand Chapter and throughout the year pins were given for 25, 40, 45, 60, 65, 70, 75 and 80 years of membership. A tradition at Ohio Grand Chapter is a Ritual Competition hosted by Past Grand Matrons and Past Grand Patrons. This year 93 competed. Competition took place for lectures of Star Points, Associate Patron, and Chaplain. Prizes for first, second, and third place were awarded for each office. There was also a Circle of Knowledge Test at Grand Chapter with 7 achieving mastery.

Ohio Grand Chapter supported several worthy causes. Special Projects of the Worthy Grand Matron included Service Dogs and the Shrine Hospital Patient Transportation Fund to honor the memory of her father. The Worthy Grand Patron's special project was our Youth. Ohio members supported several District Charities including Children's Dyslexia Centers, Youth, Heart, Education Fund, Cancer, and ESTARL. One of the fundraisers for Service Dogs raised nearly \$2,400. All districts were asked to bring a stuffed dog dressed any way they would like--and all attendees were asked to vote through monetary donations for their favorite dogs. Money was also raised to help increase security at their Eastern Star Home. This year Ohio Grand Chapter provided 16 academic scholarships to members of Jobs, Rainbow, and Demolay. The Emerald project encouraged all Chapters to beautify their local area by planting trees or flowers.

There were several types of Official Visits. Along with Schools and Fun Days, there were 5 educational opportunities with workshops during the year. Topics covered at the workshops included jurisprudence (which involved a game), protocol, Signs and Passes (new Triennial signs were demonstrated by the Grand Star Points for the membership), and an opportunity for Chapter Line Officers to meet with the corresponding Grand Officers. Another type of Official Visit was helping Chapters to celebrate anniversaries.

The Worthy Grand Matron has a personal secretary to help her with her year. The Grand Secretary had a busy year, as she was appointed a Grand Representative and, with the Grand Treasurer, hosted Secretary/Treasury Appreciation Day with 110 Secretaries and 72 Treasurers in attendance with 28 traveling companions also attending. At the Grand Session, 132 Chapters were represented. Ohio has 181 Chapters with 22,855 members. Although many Chapters in Ohio are doing well and many Chapters are welcoming new members, some Chapters face declining membership. Their Grand Line Officers meet throughout the year and their efforts included working to reverse declining membership in some of their Chapters. There is also a speakers bureau which includes the "Star Polisher" program--started to assist Chapters who want help in efforts to attract new members or revitalize their current membership.

I look forward to our virtual visits soon being in person!

### Coral Chapter, Sanborn, Consolidates with Spencer Chapter

Instituted on January 25, 1882, Coral Chapter #41, Sanborn, Iowa, met for the last time on June 10, 2021, after 139 years. In attendance were visiting members from Spencer Chapter and Twilight Chapter, Spirit Lake. For its final meeting, Coral Chapter was opened in full Ritualistic form after completing the 2020-2021 Opening March. Under Good of the Order, Worthy Matron Jane Green presented information she had gleaned from old minute books found in the attic at the Masonic Temple in Sanborn. After closing the Chapter, the members performed the Closing March. What follows are excerpts from Sister Jane's gleanings.



ORIGINAL BYLAWS (adopted March 3, 1882)



Section 1: This Chapter shall be distinguished by the name of Coral Chapter No. 41 holding an unreclaimed charter from the General Grand Chapter of the Order.

Section 2: Stated meetings of the Chapter shall be held on the 1<sup>st</sup> and 3<sup>rd</sup> Fridays of each month. The hour of meeting shall be 7:30. Meetings may be suspended during the month of July and August by a two thirds vote of the members present at a regular meeting.

Section 3: Called or special meetings may be held at any time, in the discretion of the Matron.

Section 4: Election of Officers: The annual election of officers shall be held on the regular meeting next preceding the 27<sup>th</sup> of December (Festival of St. John the Evangelist) and all officers elected or appointed must be installed on the same or at the next regular meeting.

Section 5: The elective officers are the Patron, Matron, Associate Matron, Treasurer, Secretary, Conductress and Associate Conductress. The appointed officers are the Warder, Adah, Ruth, Esther, Martha, Electa and Sentinel, to be appointed by the Matron at the time of her installation.

Section 18: Relief Committee: The Matron shall appoint three members of the Chapter as a Committee of Relief, whose duties it shall be to investigate all applications for relief made to the Chapter and report the circumstances of the case at the first meeting after receiving notice of the applicant. If the case be one of pressing necessity, the Matron may, on report of the Committee, draw an order upon the treasurer for an amount not exceeding five dollars, and the order so drawn shall be sufficient voucher for the Treasurer to pay the money. No applicant for charity shall be relieved out of the funds of the Chapter except women and orphans, children in some way connected with Free Masonry.

Section 26: Fees and Dues: The initiation fee and membership fee in this Chapter shall not be less that two dollars for a brother, nor less than two dollars for a lady, the amount to accompany the petition. The affiliation fee shall be, if the candidate has received the degrees gratuitously, the same as above, but if the candidate has previously paid for and received the degrees in another Chapter, shall pay one dollar.

Section 27: The annual dues of each member shall be one dollar per annum, payable by fifty cents at the end of six months.

Section 28: Penalties: Arrears for dues for more than one year may subject a member to be stricken from the roll of this Chapter. Any member so stricken from the roll can only be reinstated by a two thirds vote of those present and payment of the arrearages.

### Coral Chapter, Sanborn, Consolidates with Spencer Chapter

First meeting of Coral Chapter was held at the Masonic Hall, Sanborn, Iowa; January 23<sup>rd</sup>, 1882:

"The following Master Masons; A. G Willis, W. E. Skinner, E. F. Parker, P. Miller, W. Day, E. A. Brouditch and Geo. Oluistead, with Mrs. Jennie Perry, Charlotte Puffer, Julia Oluistead, Cora E. Willis, Ella Brouditch, Julia W. Skinner, and Miss Ella Skinner met at 8 o'clock for the purpose of organizing a Chapter of the Order of Eastern Star, having with us the Grand Matron Mrs. Jennie Matthews, who as the meeting was called to order, proceeded to give a brief history of the order together with its objects, benefits, etc.

"The obligation was conferred on the Brothers and Sisters present. Brother Willis acting as Marshal. Sister Perry was installed by the WGM as the WM. Sister Oluistead was installed Associate Matron, Brother Day as Worthy Patron, Sister Willis as Secretary, Sister Brouditch as Associate Conductress, Sister Ella Skinner as Adah, Brother Willis as Sentinel. The ceremony of initiation was explained." The meeting dates were first set for the 2<sup>nd</sup> and 4<sup>th</sup> Tuesdays.

The dates of the meeting changed to the first and third Tuesdays on May 23, 1883. Those voted to become members were initiated the same night they were presented. After a short recess, the "bylaws were suspended for the purpose of balloting. The candidates being in waiting were secured and initiated in regular form."



<u>February 5, 1884</u>, "the Worthy Matron being absent, the Associate Matron called chapter to order. The GWM being present, she was invited by the Associate Matron to preside as Worthy Matron; received 2 petitions; then initiated 2 others in waiting who were previously elected."

June 23, 1888, "Coral Chapter met in special meeting instituted by GWM Sister Ercanbrack for the purpose of investigating the work of our Chapter. Trying to establish uniformity of work in the chapters throughout the state."

September 15, 1891, "Our WM (F.E. Inman) entertained us by reading a full account of Grand Lodge proceedings which she had prepared herself. She had the honor of being appointed Grand Esther which is certainly a compliment to Coral Chapter. Worthy Matron's expenses to be paid to Grand Lodge was on motion of the Lodge. It was allowed and order drawn on treasury."

<u>September 5, 1893,</u> "A communication from RW Grand Secretary ... asking that each chapter send \$1 to assist in keeping open Eastern Star Headquarters at the World's Fair was read. Secretary instructed to send the amount."

March 25, 1898, "Chapter opened in form, prayer by Chaplain, singing Ode 2, after which a school of instruction was held by our Grand Worthy Patron Wessley Geiger of Marion, Iowa. The work of the Chapter was exemplified and a pleasant and interesting session was held."

#### CHAPTER HISTORY ~ BY JANE GREEN

White Ray Chapter #456, Larchwood, Iowa, instituted July 5, 1912; consolidated with Rock Rapids Chapter #288 on September 16, 1946

Starlight Chapter #433, Rock Valley, Iowa, instituted on February 16, 1910; consolidated with Rock Rapids Chapter #288 on October 13, 1970

Rock Rapids Chapter #288, Rock Rapids, Iowa, instituted on May 22, 1900; consolidated with Century Chapter #298, Orange City, Iowa, on September 4, 2001

Century Chapter #298, (originally Alton, Iowa, later moved to Orange City, Iowa, in November, 1937), instituted in 1900 (NOTE: An exact date was not found – they held their 50<sup>th</sup> anniversary in 1950; the first minutes located were for September 13, 1910); consolidated with Coral Chapter #41, Sanborn, Iowa, on December 31, 2012

Lone Tree Chapter #442, Everly, Iowa, instituted on January 31, 1911; consolidated with Golden Sheaf Chapter #181, Hartley, Iowa, on November 10, 1965

Golden Sheaf Chapter #181, Hartley, Iowa, instituted on June 6, 1895; consolidated with Coral Chapter #41, Sanborn, Iowa, on April 9, 1980

Sweet Brier Chapter #299, Paullina, Iowa, (instituted date not located), The first mention of this chapter was in Primghar minutes of February 9, 1966, when Primghar was invited to their school of instruction and inspection meeting. Then, in the minutes of January 11, 1967, it was reported "that Paullina Chapter has a floor cloth that we might be able to purchase with Grand Chapter permission." It is assumed they consolidated with Primghar Chapter.

Primghar Chapter #241, Primghar, Iowa, instituted June 22, 1898; consolidated with Coral Chapter #41, Sanborn, Iowa, on November 24, 1975

Victory Chapter #498, Sutherland, Iowa, under dispensation on May 27, 1920, previously known as Sutherland Chapter #82, which was formed under dispensation on April 11, 1890, (NOTE: This information was located in a Sutherland history book as the Chapter minutes were burned in the fire.) It consolidated with Coral Chapter #41, Sanborn, Iowa, on September 10, 1997

Floyd Chapter #220, Sheldon, Iowa, instituted April 15, 1897; consolidated with Coral Chapter #41, Sanborn, Iowa, on September 9, 1987

Coral Chapter #41, Sanborn, Iowa, instituted January 25, 1882; consolidated with Evening Shade Chapter #116, Spencer, Iowa, on June 30, 2021, after 139 years.

"The ninth annual session of the Grand Chapter of Iowa, Order of the Eastern Star, was held in the Masonic Temple in the city of Des Moines, convening on the evening of June 3d, A.D., 1886, and was called to order by the Grand Matron, Mrs. M. (Mary) C. Agnew (of Keokuk) and opened in due form." (This was her second of two years serving as Grand Matron.) There were only 15 installed Grand Officers and 12 were in attendance. The Associate Grand Conductress served as the Grand Conductress for the session and there were protems for the Associate Grand Conductress, Grand Martha and Grand Electa. There was no Grand Chaplain, Grand Marshal or Grand Organist; however, a Marshal was appointed to serve for the Installation of Officers before the close of the session.

"T. R. (Thomas Russell) Ercanbrack of Anamosa was serving his fourth of four years as Grand Patron and his almost seven-page address was the first order of business. He began by stating: "...the Grand Chapter of Iowa, like all other human organizations, had a feeble beginning. The members of the Order are not familiar with our early history. It occurred to me that for my valedictory address as Grand Patron, I could do no better service than to make a sketch of our history thus far, as gathered from our printed proceedings.

"Nearly eight years ago, that is on July 30, 1878, there met in the Masonic Hall at Cedar Rapids, twelve persons who had received the degrees of this Order in Chapters holding what are known as Macoy Charters. They hailed from seven different Chapters, some of them remote from each other, but all of them holding out a fraternal hand to be grasped.

"During the next year, on May 13, 1879, eight of the twelve reassembled at the same place. They met five others, and the thirteen composed the Grand Chapter at its second state session. Seven Chapters were again represented, though twelve chapters sent in returns. From these returns it appears that there were 356 regular members of the constituent Chapters. The Grand Treasurer had received \$168.06, of which sum the Grand Officers had expended \$80.91, leaving \$87.15 to be appropriated by the Grand Chapter.

"The third annual session was held at Council Bluffs, May 11, 1880, and for the first time in a city containing a constituent Chapter. This circumstance rendered this meeting more cheery than any which preceded it. Nine chapters were represented. Fifteen Chapters were on the roll; thirteen of which

reported, showing a membership of 468-a gain of 92. Twenty-seven persons present were entitled to participate in the deliberations, and the members of Harmony Chapter were generally in attendance. For the first time in the history of our Grand Chapter the delegates present outnumbered the offices to be bestowed.

"May 10, 1881, our Grand Chapter held its fourth session at Charles City. Ten Chapters were represented and twenty-five persons took part in the deliberations. Fourteen Chapters were on the roll with a membership of 413, showing a decrease of 55 from 1880. The revenue was \$155.00, but available cash on hand was only \$15.68.

"The fifth annual session convened at the Masonic Hall in Des Moines, June 6th 1882, with thirty-seven voting members hailing from thirteen different Chapters. Twenty-five Chapters were on the roll; nineteen reported a membership of 855, a gratifying increase of 442 or more than 100 per cent.

"A very pleasant session was that at Mount Pleasant, May 22 and 23, 1883. Forty voting members were present, fifteen of our thirty-three Chapters being represented. Twenty-nine Chapters sent returns showing a membership of 1,192, an increase of 387. The several Chapters paid to our treasury \$272.55 and the Treasury carried a balance of \$48.92.

"At Grinnell, June 10 and 11, 1884, our Grand Chapter held its seventh annual session. Nineteen Chapters sent delegates, and forty voting members were present. The members of Beulah Chapter filled the remaining space in the Hall, and rendered the occasion delightful. Of the forty-one Chapters that once existed, twenty-six reported a membership of 1,556. The Grand Treasurer has a balance on hand of \$151.39. The Grand Matron of New Jersey was assisted with the Installation of Officers.

"Our eighth stated meeting was distinguished by the peculiar feature that it was held in the beautiful hall of the Masonic Library in Cedar Rapids, and Grand Secretary (Theodore) Parvin, of A.F and A.M. (Grand Lodge of Iowa), set everything in order and was made a life member of the Grand Chapter. Forty-six Chapters appeared on the rolls and twenty-one sent delegates to Grand Chapter. The returns showed a membership of 1,647. The year's revenue was \$458.14, but when the expenses of the session had been paid, the treasury was exhausted."

Brother Ercanbrack concluded his lengthy address with the following admonition: "But we are not entirely beyond the possibility of serious calamity. The Grand Matron and Grand Patron could tell you of pitfalls that future Officers may fall into. It is to be hoped that they will be possessed of the wise discretion to ignore trifles, to be deaf to unkind criticism and to keep an eye single to F.A.T.A.L."

The Annual Address by the Grand Matron was also very long and very eloquent compared to present day speaking. "Again through the divine providence of God we have been permitted to meet and assemble at the ninth annual session of the Grand Chapter of Iowa. Although a goodly number have been able to come forth on this occasion, many have been called to a higher life, as the stern Reaper has entered our ranks during the past year, taking some our most zealous and earnest workers. Yet, while we mourn, we must remember that our loss is but their gain.

"The outer world sees no good in secret Orders, like the infidel who cannot fathom the deep mysteries of God's ways and understand the immutable laws of the Most High, refusing to bow to the mild precepts of His holy will, thereby seeking to raise himself higher than the Son, who did not know all the secrets of the Father... Is it any wonder that the time-honored institution to which we cling for protection and support should stand on such a foundation from time immemorial, witnessing the uprising and downfall of empires, withstanding all the ravages of time. Look at her, a monument in the dim ages of the past. She is growing at the present, and will continue to grow through all the ages to come... Her fraternal chain encircles the globe. Her mission is one of peace and love and brotherhood. Let us strive to follow closer the examples of this grand institution."

With regard to organizing new Chapters, Mrs. Agnew noted: "I have made quite an effort to assist in forming new Chapters, but not with as great success as I should have liked. I have also endeavored to revive some of our sleeping Chapters by visiting... Some have displayed signs of life by asking for dispensations, but failed to recover energy enough to revive. I fear they are past restoration." (Continued on Page 12)





Mrs. Agnew organized Chapters in Murray, Runnells. Abingdon and Sac City during the year and on August 5th, Signet Chapter No. 1 of Carroll was reorganized and their Macoy Charter was exchanged for a Grand Chapter Charter. "This Chapter started out under very favorable circumstances; over fifty charter members being present." (**NOTE**: If I understand correctly, the Chapters that were in existence when the Grand Chapter of Iowa was organized on July 30, 1878, DID NOT automatically become a part of Grand Chapter. It was necessary for these Chapters to relinquish their Macoy Charters in order to receive a Charter from Iowa Grand Chapter. It is unfortunate that there is not a complete list of Chapters which held Macoy Charters.)

In her address, Mrs. Agnew noted that she had used over 700 letterheads, and had been out of supply for some time. She also noted that: "... unfortunately the team which was conveying me to the depot ran away and I lost my letter register and quite a number of important memoranda which must have been buried in the mud as we failed to find any trace of them; therefore I cannot give you a very exact account of stamps. I can only say that my correspondence, which has been much more extensive than last year, has been wearisome." She concluded her remarks by saying: "Yes, while memory lasts a sweet remembrance of these few brief months will ever remain, a sweet recollection, and as I return to the bosom of my family I shall only carry with me these pleasant recollections."

She passed away on December 1, 2020, having lived a wonderful life of fidelity, constancy, loyalty, faith and love.
